BUSINESS LICENSE FEES

1. BUSINESS LICENESE TRANSFER

- 1.1 The business license transfer fee shall be:
 - a) Ten dollars (\$10.00)

2. CONTRACTOR – CONSTRUCTION (Fees do not include sub trades.)

2.1 Resident

The business license fee for one (1) year shall be:

- a) Thirty-five dollars (\$35.00) for a contractor that is a resident business
- b) One hundred fifty dollars (\$150.00) for a contractor that is not a resident business but that is a resident.

2.2 Non-Resident

The business license fee shall be:

- a) One (1) day Fifty dollars (\$50.00)
- b) One (1) week Seventy-five dollars (\$75.00)
- c) One (1) month one hundred dollars (\$100.00)
- d) Six (6) months one hundred fifty dollars (\$150.00)
- e) one (1) year two hundred dollars (\$200.00)

3. CONTRACTOR – GENERAL

3.1 Resident

The business license fee for one (1) year shall be:

- a) Thirty-five dollars (\$35.00) for a general contractor that is a resident business
- b) One Hundred fifty (\$150.00) for a general contractor that is not a resident business but that is a resident

3.2 Non-Resident

The business license fee shall be:

- a) One (1) month One hundred fifty dollars (\$150.00)
- b) Six (6) months Three hundred dollars (\$300.00)
- c) One (1) year Five hundred dollars (\$500.00)
- 3.3 The fee under Contractor General includes all subtrades used on a construction project.

4. FARMERS MARKET

- 4.1 Agents, businesses or persons that operate at the Farmers Market but do not comply with Farmers Market Guidelines shall pay a business license fee of:
 - a) Resident One (1) year Thirty-five dollars (\$35.00)
 - b) Non-Resident One (1) year Two hundred dollars (\$200.00)

5. HAWKER/ PEDLAR

- 5.1 The business license fee shall be:
 - a) One (1) day Thirty-five dollars (\$35.00)
 - b) Resident One (1) year One hundred fifty dollars (\$150.00)
 - c) Non-Resident One (1) year Two hundred dollars (\$200.000)

6. HOME OCCUPATIONS

- 6.1 The business license fee for all Home occupations shall be:
 - a) One (1) year One hundred fifty dollars (\$150.00)

7. HUSKY PLAZA MALL RENTAL CONTRACT

- 7.1 The business license fee shall be:
 - a) Agent, business or persons with a signed Husky Plaza Mall Rental Contract One (1) year Thirty –five dollars (\$35.00)

8. NON-RISDENT BUSINESS

- 8.1 The business license fee shall be:
 - a) One (1) year Two hundred dollars (\$200.00)

9. NON-RESIDENT SPECIAL SALE

The business license fee per occurrence shall be:

a) Five hundred dollars (\$500.00).

10. RESIDENT BUSINESS

- 10.1 The business license fee shall be:
- a) One (1) year Thirty-five dollars (\$35.00)

11. RESIDENT GARAGE SALE

- 11.1 Resident garage sales shall be held be the occupant of the residential swelling or necessary residential building and be limited to the sale of privately owned goods.
- 11.2 The business license shall be:
 - a) First two (2) sales from the same location No fee
 - b) Third and subsequent sales Twenty-five dollars (\$25.00)

12. SEASONAL BUSINESS

- 12.1 The business license fee shall be:
- a) Seventy-five dollars (\$75.00) for a resident business per seasonal term
- b) One hundred fifty (\$150.00) for a non-resident business per seasonal term

13. TRADE SHOW

- 13.1 The Business license fee shall be:
- a) One hundred dollars (\$100.00) per event
- 13.2 Trade Show organizers must provide the Town of Vegreville with a list od participants along with their mailing addresses and phone numbers prior to the event.
