#2017-OCT-55 PAUL SUITER, COMMUNITY SERVICES DIRECTOR – 2018 FCSS ANNUAL FUNDING AGREEMENT

A Request for Council Decision dated October 19, 2017 from Paul Suiter, Community Services Director stating:

To enter into an agreement with the Minister of Human Services for the Family and Community Support Services Funding for January 1 – December 31, 2018.

The FCSS program funding agreement for 2018 is provided in advance of the completion of the provincial 2018 budgetary process.

The Town of Vegreville will receive the funding as four (4) quarterly payments (January, April, July & October) to the total of \$164,163.

This is the same amount as was in the 2017 agreement.

Grant funding of \$164,163 is provided by the province with a minimum of 20% (minimum) municipal matching share of \$41,041 to a total of \$205,204 is required to be allocated to FCSS programs and services.

By acceptance of the funding, the agreement states that the Municipality shall:

- a) provide for the establishment, administration and operation of a Family and Community Support Services Program ("the Program") in accordance with the Family and Community Support Services Act and Regulation;
- b) use the total amount of \$205,204 including the required municipal contribution of at least \$41,041 to deliver the program.

This agreement requires signatures from the Mayor and Town Manager then return to Alberta Human Services for signatures. Once signed a copy will be returned for filing.

Councillor Rudyk moved that the Town of Vegreville enter into the 2018 FCSS Program Funding Agreement for the period of January 1 through December 2018.
