

BYLAW NO. 10 - 2022 TOWN OF VEGREVILLE

THIS BYLAW NO. 10-2022 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA TO ESTABLISH THE ECONOMIC DEVELOPMENT COMMITTEE FOR THE TOWN OF VEGREVILLE.

WHEREAS Section 145 of the *Municipal Government Act*, RSA 2000, Chapter M-26, and amendments thereto, provides that a Council may pass bylaws to establish council committees and to define their functions;

AND WHEREAS Council wishes to establish a committee known as the Economic Development Committee to promote economic development within the Town of Vegreville.

NOW THEREFORE the Council of the Town of Vegreville in the Province of Alberta, enacts as follows:

1. TITLE

1.1 This Bylaw may be cited as the **Economic Development Committee Bylaw**.

2. DEFINITIONS

- 2.1 Committee means the Economic Development Committee;
- 2.2 Council means the elected governing body of the Town of Vegreville;
- 2.3 Town means the municipal corporation of the Town of Vegreville.

3. ESTABLISHMENT

3.1 The Economic Development Committee is established as a Committee of Council under this Bylaw.

4. MANDATE

4.1 The mandate of this committee is to streamline/share information between municipal departments related to economic development activities, as well as to foster partnerships/collaboration with external organizations and businesses.

5. MEMBERS

- 5.1 The committee will be led by a Chair. The Chair is to be nominated and elected by the Committee members.
- 5.2 Committee Members:
 - (a) Mayor
 - (b) One (1) Councillor who sits on the Chamber of Commerce Board
 - (c) One (1) Councillor who sits on the Vegreville Tourism Advisory Board

5.3 Support Staff:

- (a) Economic Development Manager
- (b) Communications & Marketing Manager
- (c) Planning & Development Coordinator
- (d) Tourism, Recreation & Culture Coordinator
- (e) Chief Administrative Officer

6.1 The Committee will meet a minimum of six (6) times per year.
