

BYLAW NO. 09-2025 TOWN OF VEGREVILLE

THIS BYLAW NO. 09-2025 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE FOR THE APPOINTMENT OF A MUNICIPAL ASSESSOR AS A DESIGNATED OFFICER FOR THE TOWN OF VEGREVILLE.

WHEREAS, Section 210 of the Municipal Government Act, RSA 2000, Chapter M-26, and any amendments, the Council of the Town of Vegreville may pass Bylaws to establish one or more positions to carry out the powers, duties, and functions of a Designated Officer.

AND WHEREAS, Section 284.2 of the Municipal Government Act, RSA 2000, Chapter M-26, and any amendments, requires that a Municipal Assessor be appointed as a Designated Officer of the municipality.

NOW THEREFORE, the Council of the Town of Vegreville, duly assembled, enact the following:

1. TITLE

1.1. This Bylaw may be cited as the **Appointment of Municipal Assessor Bylaw**.

2. **DEFINITIONS**

2.1. Municipal Assessor means

- 2.1.1. A person who has the qualifications set out in the Municipal Government Act Qualifications of Assessor Regulation 233/2005, as amended.
- 2.1.2. Is appointed by the municipality by Bylaw to the position of Designated Officer to carry out the duties and responsibilities of a Municipal Assessor under the Municipal Government Act.
- 2.2. **Designated Officer** means the person designated pursuant to Section 2.1 herein.
- 2.3. Contractor means an independent party to the Town of Vegreville serving under a contract to provide municipal assessment services and shall not be deemed to be an employee of the Town of Vegreville.

3. DESIGNATED OFFICER POSITION

3.1. That the position of Municipal Assessor as a Designated Officer for the Town of Vegreville is hereby established.

4. APPOINTMENT OF ASSESSOR

4.1. That Bob Daudelin be appointed as a Designated Officer for the purpose to carry out the duties and responsibilities of Municipal Assessor for the Town of Vegreville.

5. REPEAL

5.1. That Bylaw 01-2023 be repealed.

6. EFFECTIVE DATE

6.1. That this Bylaw shall come into effect upon final reading.
