

BYLAW NO. 06 – 2019

TOWN OF VEGREVILLE

THIS BYLAW NO. 06-2019 OF THE TOWN OF VEGREVILLE, IN THE PROVINCE OF ALBERTA TO ESTABLISH THE SOLID WASTE COMMITTEE FOR THE TOWN OF VEGREVILLE.

WHEREAS Section 145 of the *Municipal Government Act*, RSA 2000, Chapter M-26, and amendments thereto, provides that a Council may pass bylaws to establish council committees and to define their functions;

AND WHEREAS Council wishes to establish a committee known as the Solid Waste Committee to promote waste reduction.

NOW THEREFORE the Council of the Town of Vegreville in the Province of Alberta, enacts as follows:

1. TITLE

1.1 This Bylaw may be cited as the Solid Waste Committee Bylaw.

2. **DEFINITIONS**

- 2.1 **Committee** means the Solid Waste Committee;
- 2.2 **Council** means the elected governing body of the Town of Vegreville;
- 2.3 **MASH** means municipalities, academic institutions, school boards, and health and social service providers.
- 2.4 **Town** means the municipal corporation of the Town of Vegreville.

3. ESTABLISHMENT

3.1 The Solid Waste Committee is established as a Committee of Council under this Bylaw.

4. MANDATE

4.1 The mandate of this Committee is to promote waste reduction, recycling, and resource conservation and will advocate for changes in policy to applicable levels of government; raising awareness, education, and encourage responsible waste reduction to meet the needs of the Town.

5. MEMBERS

- 5.1 The committee will be led by a Chair. The Chair is to be nominated and elected by the voting Committee members.
- 5.2 Voting Members:
 - (a) Two (2) Members of Council;
 - (b) One (1) Town resident;
 - (c) One (1) Town business/MASH Sector;
 - (d) Up to two (2) County of Minburn No. 27 representatives (resident and/or business); and
 - (e) One (1) Research & Development representative.



5.3 Support Staff:

- (a) Infrastructure, Planning & Development Director;
- (b) Municipal Services Manager; and
- (c) Administrative Support.

6. QUORUM

6.1 A simple majority of the voting members will constitute a quorum.

7. TERM

7.1 Members of the Committee should commit to involvement of a minimum of one (1) year.

8. MEETINGS

8.1 Meetings will be held on an "as required" basis at the call of the Chair.

9. EFFECTIVE DATE

9.1 This Bylaw shall come into full force and effect upon third and final reading.
