2025 Property Tax arrears are due no later than December 31, 2025, by 4:30 pm.

An additional 15% penalty will be applied on all current property taxes that remain unpaid after December 31, 2025.

Annual Small Business Declaration Reminder

Deadline to submit is December 31, 2025

Submit your Annual Small Business Declaration Form to the Town Office by 4:30 PM on the last working day of December to qualify for the small business tax rate next year.

Forms received after this deadline will not qualify for the small business tax rate in the following year.

Eligible properties are those (excluding designated industrial) owned or leased by businesses that:

- Hold a valid Town of Vegreville business license or exemption,
- Employ fewer than 50 full-time employees in Canada, and
- Generate active business income.

Forms must be completed annually to qualify!
